AKC NEWS

The AKC Events Department has been processing numerous event cancellations due to the COVID19 virus. On the AKC website, click on "Sports/Events" then on the right side, scroll down to "Event Cancellations" https://www.akc.org/sports/event-cancellations/

The AKC has closed their New York City office and has minimum staffing at their Raleigh North Carolina offices. Many AKC personal are working from their homes. The AKC advises that their operations hours are 8:15a-4:30p EST Mon-Fri. The customer service call center will remain open until 8pm EST Mon-Fri, online registration services are available 24/7, and AKC DNA processing continues as normal. There may be delays with the postal mail processing. The AKC strongly encourage customers to use email to contact staff, use customer service as a resource, and make use of the AKC online services when applicable at akc.org. Any club that notifies the Events Department that their event is cancelled due to the COVID19 virus will automatically retain their corresponding date for 2021 unless the club asks otherwise. AKC Event Application fees which were paid for a cancelled event will be credited towards the club's next event of the same type. All late fees for event applications will be waived through October 31, 2020 in order to provide clubs flexibility in scheduling their events. A cancelled event will not count against the total number of events allowed per year. If judges are pending on a panel for not having attended a seminar, they will be excused from having to attend one for the next 12 months.

Lure coursing clubs at their option can now send copies of their results including their Secretary Report in PDF format via email to: performanceresults@akc.org. Clubs will then be contacted to confirm receipt and handle their event service fees via credit card by phone.

At the April conference call meeting of the AKC Board, the following were approved.

- (1) Modification to Limited Events Policy Clubs previously not eligible may hold a third show in connection with their show/cluster if they meet the following provisions: Must hold all of their shows within 50 miles of the club's territory, and No other shows are held within 500 miles of the show site on the day of the show or any day of the cluster.
- (2) Extend the distance conformation clubs may hold a show outside their territory from 125 miles to 200 miles. Extend the distance specialty clubs may join another specialty club of the same breed outside their territory from 200 miles to 300 miles.
- (3) Increase the number of breed specialties a local specialty club may hold from two specialties or two days of specialties per year, to two independent or concurrent specialties or two days of independent or concurrent specialties, plus up to four designated specialties.
- (4) Waive the policy restricting judges from being assigned the same breed, Group or Best in Show at events held within 30 days and 200 miles. This applies to conflicting weekends and does not apply to events on the same weekend, circuit or cluster.
- (5) Waive the same day exhibiting restriction for judges assigned only NOHS Groups and/or NOHS BIS. Judge assigned NOHS group or NOHS BIS show only may exhibit the same day, but MAY NOT compete in NOHS the same day they judge.
- (6). Allow Juniors that turned 18 on or after March 1 to compete until Oct 31. This will encompass the qualifying period for both the AKC National Championship (ANC) and Westminster.
- (7) Conformation Judges Education Free online breed education webinars presented by Parent Club Judges Education Coordinators/Presenters provide additional educational resources which may be submitted on future application for the breed. Also, all Canine College breed courses are being offered at half price thru May 31.
- (8) Waive the Public Education requirements for all-breed conformation clubs.

At the AKC Board's February meeting, it was approved to amend the NOHS regulations to create <u>NOHS Levels of Achievement</u> to include Bronze, Silver, Gold and Platinum awards. Exhibits obtaining the predetermined number of NOHS points based on the current NOHS point system will earn these designations. The primary owner of a dog achieving these levels will receive an appropriately colored NOHS pin and will be emailed a Certificate of Achievement. These awards will be grandfather back to the launch of the program. The grandfathering will recognize the highest level achieved to date. Recognition Level Minimum Level of NOHS Points Bronze 250 Silver 500 Gold 1,000 Platinum 2,000.
