#### Joel Keller Chaney October 24, 1944 – January 22, 2022

Joel and his wife Camelle lived in Ohio where they raised a daughter, Erica, and a son, Joel. They bred a couple of litters of borzoi using the kennel name Rohnoke. Their first home bred champion was finished in 1986, Ch Rohnoke's Arbor Vitae (Ch Seabury's Damon x Kelcrest Starshine). Joel was known for his quiet good humor, and good sportsmanship and was an excellent handler. Joel handled Rohnoke's Sunkist Orange to Reserve Winners Bitch at the 1989 MBC specialty at Detroit over 68 other bitches. Joel would later finish Sunny (Ch Rohnoke's Arbor Vitae x Ch Seabury's Dina). Joel handled Regius Rohnoke Moonchild to first in open, and then to winners bitch at the 2004 BCOA Specialty over 167 bitches. Joel and Camelle were BCOA members for about 20 years. They are life members of the Midwest Borzoi Club. Joel served MBC as treasurer in the 1980s. Joel and Camelle helped on committees and at numerous events. Joel was the Midwest regional vice president of BCOA 1991-1994, was on the staff of the Borzoi Connection magazine (1997 - ), and served on the show committee for the BCOA national specialty in Ohio in 2004. They then gradually phased out of borzoi to show and breed Maine Coon cats. Joel will be missed by many.

### Amy Baltrop/Akanni

Akanni has a new champion with all points earned from the Bred-By class - Satine is now CH Akanni's Spectacular Spectacular SC. She earned her second major at the Michigan Hound Association show in Novi and her last point that Sunday at the Oakland County Kennel Club show. In November, Satine tied for 5th place in the Saturday breed hunt at the 2021 Borzoi Fall Classic two-day open field coursing event, and for the second year she was in the Over-All Top Five for the weekend, this year tying for 4th place out of eleven dogs running. We have an exciting breeding planned for her if she ever decides to come into season. Serenity - CH Howff Carbobonel Firefly at Akanni JC - earned her first major over Chs towards her GCH at the same Michigan Hound Association show. Serenity also earned her JC title and has 2 legs to her SC title and she was fourth place in the Saturday breed hunt of the 2021 Borzoi Fall Classic. Elphaba - Akanni's Defying Gravity - attended her first ever all-breed shows in Columbus, earning RWB to the 5 point major the first day. She then went to her second all-breed show and earned her first point. We're hoping that we can get her out in earnest this year.

## Steve & KC Artley/Tahoe

In the four shows we have attended in 2022, our tri spotted male, GCH Windrift Longshot At Tahoe JC earned 11 more GCH points. Our self-red female, Desertwinds Aruzia Fun With Tahoe's Skye CGC won 2 single points at the Medina shows, a major at the Warren County show, and her first leg for the Rally Novice title at the Hamilton trial.

#### **AKC NEWS**

The American Kennel Club has launched the AKC **National Owner-Handled Series Levels of Achievement** that offers Bronze, Silver, Gold and Platinum recognition to exhibits obtaining a predetermined number of NOHS points for each level of award. The NOHS Levels of Achievement utilizes the same NOHS point system used to determine the annual rankings for the NOHS. The Bronze 250 points, Silver 500 points, Gold 1000 points and Platinum 2000 points. NOHS Levels of Achievement are earned by obtaining a minimum number of lifetime NOHS points. The AKC is providing a

commemorative pin and a downloadable certificate for the highest Level of Achievement the dog had earned (using lifetime NOHS points) at the time of program implementation.

The temporary COVID provisions that have been made permanent are:

- 1. Conformation All-Breed Conformation shows with an entry limit are required to publish their premium list at least 72 hours prior to accepting entries.
- 2. Conformation Individuals judging NOHS groups or BIS only may exhibit in regular competition on the day they judge.
- 3. Conformation Allow Specialty clubs to hold up to four designated specialties in addition to the independent/concurrent specialties.
- 4. Judges Education The Breed webinar series was started due to COVID and has now been made permanent.
- 5. Obedience/Rally/Agility Allow clubs to close no later than midnight seven days prior to the event. (Previously it was 2½ weeks for O/R and 10 days for Agility).
- 6. Obedience Modify the Figure 8 exercise to use of cones instead of Stewards.
- 7. Obedience/Rally Reduce to 10 days prior to the event the restriction on exhibitors and dogs that participate in a training session taught by a judge (previously it was 30 days).
- 8. Obedience/Rally Eliminate the restrictions on exhibitors and dogs exhibiting to a judge when there is an emergency judge change.
- 9. Rally Allow clubs to distribute course maps no earlier than 6 PM the evening before the trial. (Previously it was no earlier than the morning of the trial.)
- 10. Agility Allow handlers to carry their leash in their pocket or around their waist.
- 11. Canine Good Citizen Test Eliminated the handshake in the CGC test. Now it is a friendly greeting and simulated handshake.

The AKC Board voted to amend Chapter 2, Section 27 of the Obedience Regulations to make Fix n' Go a permanent enhancement to the sport of obedience at the end of the pilot program. This is a change to the Obedience Regulations and will become permanent on April 1, 2022. The amended language in the Regulations will be as follows:

Obedience Regulations - Chapter 2, Section 27. Training and Handling in the Ring. When a handler is using excessive verbal commands, this could indicate the dog is not under control and is not working with the handler willingly. The judge must determine if this dog should be released for a lack of control. The handler is not allowed to correct or discipline a dog and will be released from the ring. When the dog's performance does not meet the handler's expectation, the handler may choose to use a "Fix n' Go" option once, which allows the exhibitor to immediately reattempt a single individual exercise. This allows the team to reattempt that one exercise, and then leave the ring. In a two-part exercise, the handler may choose only one part to reattempt. It is the handler's responsibility to tell the judge they are choosing to "Fix n' Go." Using the Fix n' Go option will result in a non-qualifying score (NQ). The handler may begin the reattempt from the start or at any point during the exercise. The handler may choose to help the dog through the Fix n' Go exercise. Helping the dog may be accomplished using verbal encouragement, including additional commands and praise, and/or approaching the dog in a friendly/positive manner without touching the dog. Harsh verbal and /or physical corrections will not be tolerated. If there is any determination of harshness by the judge, the handler will be immediately released from the ring.

This COVID provision has expired: allowing event applications and judges panels to be submitted later than their normal due date. Applications and judges panels must be submitted eighteen weeks prior to the closing date of the event.

Obedience – The modified distance of eight (8) between dogs in the Novice obedience group exercises will return to a distance of six feet between dogs, for all events held after December 30, 2021.

Obedience/Rally/Agility – Two-Judge Requirement to Title – The Board extended the temporary modification for obedience, rally, and agility lower level classes and will allow titles to be earned under a single judge through December 31, 2022.

Obedience/Rally/Agility – The waiver of date and mileage restrictions for judges – The Board extended the temporary modification for obedience, rally and agility judges and waived the date/location restrictions of 30 days and 100 miles for obedience/rally judges; and 30 days and 200 miles for agility judges, allowing them to accept assignments without a conflict through December 31, 2022.

Obedience/Rally – The judge's assignment limitation to judge the same classes – The Board extended the temporary modification for obedience and rally trials and will allow a judge to judge the same classes at more than two trials over the course of a cluster of no more than five days through December 31, 2022.



#### 2020 MBC Hall of Fame Service Award

Service award Requirements are as follows:

- \* Member of Midwest Borzoi Club, in good standing with the MBC, affiliate clubs and the American Kennel Club for a minimum of 15 years.
- \* Must have served on a minimum of 2 committees and completed the job in an adequate fashion.
- \* Must have adhered to the Midwest Borzoi Club Ethics Guidelines.

Our Hall of Fame recipient purchased her first Borzoi in 1982, which sparked a almost 40 year love of the breed. Breeding under the prefix: "Nonsuch" with her sister, the kennel located in Redgranite, WI produced over 100 American Champions. At Nonsuch they developed a definite style or "look", and dedication to the breed that took Kalen not only all over US, but all over the world. Kalen shared, "I can honestly say that if it wasn't for my Borzoi/Dog show "Family" I would never have had the opportunity to meet so many wonderful people, from all walks of life.

I'm extremely proud of my dogs and their many accomplishments, and would do it all over again if given the opportunity".

Kalen served for many years as a club board member and Vice-President. In addition she was co-show chair for several MBC supported shows. She is thrilled to have been chosen to receive the Service Award from her fellow Borzoi lovers.
